We are a forensic psychology private practice located in downtown Little Rock, Arkansas. We conduct psychological evaluations across a range of referral questions which broadly fall into the areas of criminal, personal injury, employment, disability, immigration, and family law.



ABOUT OUR FELLOWSHIP

Our fellowship provides intensive training in forensic psychological assessment. Fellows focus their training in the areas of criminal, disability, and immigration law cases. Fellows receive supervision, opportunities to testify and observe testimony; assessment experience in prisons, jails, and hospitals; and training across a year-long forensic psychology didactic sequence.

CRIMINAL CASES

Criminal evaluations fellows conduct and receive training in include criminal responsibility, fitness to proceed, culpable mental state, restorability, and violence risk.

IMMIGRATION CASES

Immigration evaluations fellows will conduct and receive training in include evaluations for a U-Visa, VAWA, hardship, and the citizenship test waiver.

DISABILITY CASES

Fellows will receive training and experience conducting evaluations for the Social Security Administration including testing for intelligence, memory, and academic achievement.

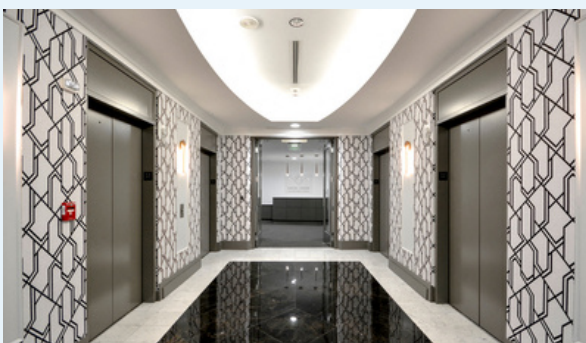
WHAT WE OFFER



In addition to the training, supervision, and forensic/clinical experience, fellows will receive benefits (e.g., health, vision, and dental insurance), vacation, and an annual income of approximately \$60,000 to \$90,000 based on performance.

SUPERVISION



Supervision is provided at least weekly by Benjamin Silber, Ph.D., ABPP. Supplementing the supervision and didactics he provides, didactic training is provided by several other forensic psychologists and neuropsychologists.

DIDACTICS



Didactic topics for the fellowship year include criminal responsibility, malingering, fitness to proceed, mitigating circumstances, establishing a private practice, threat assessment, violence risk assessment, neuropsychological assessment, disability assessment, culpable mental state, psychometrics and test limitations, report writing, board certification preparation, capacity to waive Miranda rights, landmark case law, testimony, death penalty cases, neurological bases for morality, personal injury, the phenomenology of hallucinations, and the Arkansas legal system, amongst other relevant forensic psychology topics.

PRIMARY SUPERVISOR



Following training in psychological assessment and forensic evaluation at Patton State Hospital, Dr. Silber completed a predoctoral internship at the federal correctional complex in Butner, NC where he received further training in forensic psychology and the treatment of serious mental illness. He completed a formal postdoctoral fellowship in forensic psychology at the Arkansas State Hospital and obtained a position as a forensic psychologist there the following year. That same year, he also started Expert Psychological Evaluations. Dr. Silber has a tireless and dedicated passion for forensic psychology and continues to pursue advanced training. He is certified as a Specialist of the American Board of Professional Psychology in Forensic Psychology and is a Fellow of the American Academy of Forensic Psychology. He has supervised postdoctoral fellows in forensic psychology at the Arkansas State Hospital and now does so in his private practice.



APPLICATION REQUIREMENTS



To apply, you must have a Ph.D. or Psy.D. in clinical or counseling psychology from an APA accredited university, an APA accredited pre-doctoral internship, and eligibility to work in the US. Prior experience with forensic assessment is preferred. The fellowship year begins September 1.
